## GENERAL TERMS & CONDITIONS OF MEMBERSHIP

- a) All members are required to strictly adhere to the Rules and By Laws of the Chamber

- g) Members who fail to renew by December 31 will be considered **lapsed** and must re-apply as **new members**, including payment of the one-time registration fee.
- h) Membership fee rates may be adjusted with notice given to members prior to the next fee renewal date
- i) All fees are **non-refundable** and **non-transferable**.
- j) Membership benefits, terms, and categories are subject to periodic review and may be updated by MCCI Membership Committee
- k) The Board of Directors reserves the full rights to reject, put on hold, terminate or ban any membership at anytime for any reason whatsoever deemed fitting by The Board of Directors
